### **1. EXECUTIVE SUMMARY**

### **1.1 INTRODUCTION**

#### **Introductory Note :**

Navgan Shikshan Sanstha Rajuri's, Arts & Science College, Chousala, Tq. & Dist. Beed (Maharashtra) is established in 1994. It was started by Navgan Shikshan Sanstha Rajuri's Education society which has been rendering valuable service in the field of education to the residents of Beed district for last 48 years. The foundation stone for the college was laid down by hon. Dr. Bharatbhushan Kshirsagar, Secretary of Navgan Shikshan Sanstha.

Our institution is located in rural and unprivileged area of Marathwada region, i.e. in Chousala village of Beed district on Solapur- Dhule national highway. Our institution has 2(f) and 12(B) status. We run Arts & Science faculties. Our college is affiliated to Dr. Babasaheb Ambedkar Marathwada University, Aurangabad. We provide co-education to the students. In Arts faculty we teach Marathi, Hindi, English, Sociology, Political Science, History, Economics ,Geography, Physical Education, Home Science and Public Administration subjects. For P.G. programme we have Marathi, Hindi, History, Sociology, Political Science and Geography subjects. In Science stream we have Physics, Chemistry, Botany, Zoology and Computer Science.

### **1.3 CRITERIA WISE SUMMARY**

### **Curricular Aspects**

### **Criterion I: Curricular Aspects:**

As our institution is affiliated to Dr. Babasaheb Ambedkar Marathwada University, Aurangabad we follow the curriculum and syllabus framed by it. The institution ensures effective curriculum planning and delivery through well-planned and documented process. The institute prepares its Academic Calendar in line with the Academic Calendar of the parent University. The faculty prepares Semester-wise teaching plan. Individual time table is prepared by the faculty. Daily Teaching diary is maintained. Each department conducts Continuous Internal Evaluation of the students by taking class tests, tutorials, assignments, etc. Our faculty members work as examiners, paper setters and engage in the work of evaluation of the students in practical exam, Project work , Internal and External assessment.

The institution integrates crosscutting issues relevant to Professional Ethics, Gender, Human values, Environment and Sustainability into the curriculum. A program on Women Empowerment and Gender Equality is organized by the institute. International Women's Day is celebrated by the institute. Every year on the occasion of International Yoga day the related activities are conducted for the physical as well as mental health of the students, staff and the society. The institute celebrates Constitution Day every year. The values of Social ethics are included in the syllabus of Sociology. The institution undertakes tree plantation program at college campus as well as outside the college campus. No vehicle day is observed on I & III Saturday. At UG level the compulsory paper for environmental studies is taught for all the disciplines. The institution invites feedback from the stakeholders like Students, Alumni, Parents, etc., regarding the curriculum delivery. The rendered

suggestions from the stakeholders are taken into consideration and are worked upon and the other facilities provided by the institute.

#### **Teaching-learning and Evaluation**

#### **Criterion II: Teaching, Learning and Evaluation**

The admission process of the students is transparent. The students are admitted on first come first basis. All the norms and regulations of UGC and State government are followed by the institution. Seats are filled according to the seats reserved for various categories (SC,ST,OBC,SBC,Gen, etc.,) as per applicable reservation policy. All the rules, regulations & qualifications are followed for the selection of the faculty. Our teaching staff is qualified and meritorious members in the staff. The faculty keeps pace with recent developments through the participation in national /international seminars, conferences, workshops, orientation courses, refresher courses, etc. Our college focuses on Students' involvement in learning process. In regular classes the students are made to participate in discussions and interactions. The subjects like Geography, Physical Education and Home Science are practical oriented. The students are guided by the teachers to write projects. In this way the research aptitude of the students develops. The faculty use audio-visual aids, multimedia, ICT, computer and internet facility. For the knowledge of students Program outcomes and Course Outcomes for all programs offered by the institution are stated and displayed on website of the institution. Students are educated with the outcomes of each course before the commencement of the classes of the respective subjects. Semester wise Class Tests and Tutorials are conducted by the respective departments. The concerned subject teachers conduct a personal interface meeting with the students. The students are apprised of their strengths and weaknesses for further improvement.

### **Research, Innovations and Extension**

### Criteria III: Research, Consultancy and Extension:

We have, in our college Research committee to facilitate and monitor research activities. This committee helps to promote the members of faculty to pursue their research activities by providing them Library facility, leaves etc. Most of our faculty members have completed their Ph.D. research and some are recognized as research guides. Our institution promotes the students to take active part in research activities.

Our faculty members Dr. M.G.Rajpange published his books entitled "Bharat ka Prakartik Bhugol", & " Paryawarniya Bhugol". Dr. Vilas Bhillare has published hei book entitled "Educational Works of Mahatma Jyotiba Phule" and his other book is "A Sociological Study of Intercaste Marriages in reference to Beed district". Our faculty members have published many research papers in State, National & International Level Journals. They have also participated in many conferences, seminars and workshops.

Through NSS department the institution organizes various program like celebration of birth anniversaries of national leaders, social workers, etc. Every year our institute organises a blood donation camp. The institution has planted many saplings in the premises of the institution and also outside. The institute has participated in Atal Ghanwan Yojana. Every year our institute conducts a camp for health checkup of the pilgrims who go for Muktai dindi. The most notable activity which the institute undertakes every year is that our institution helps the families of farmers who have committed suicide. It helps those families by donating them the floor mil, goats, sewing machines etc. for their daily earnings. All these initiatives contribute in holistic development of the personality of participants, so that committed and ethically informed citizenship is created.

#### **Infrastructure and Learning Resources**

#### **Criterion IV: Infrastructure and Learning Resources:**

We have a beautiful, fresh and airy college building surrounded by a beautiful garden, thick trees and plants. We have well ventilated classrooms, spacious auditorium for cultural programs and various academic functions. We have separate department rooms & reading room. We have rich library with almost all types of reference books, text books, magazines, journals and periodicals of state and national level. Reprographic (Xeroxing) facility is made available to the students. Library services are Partially Automated .The college also has updated computer laboratory. We have Geography, Physical Education, Home Science and Science laboratories.

We have a spacious playground in the campus itself. We have the facility for outdoor and indoor games. In outdoor sport we provide facility of sports like Cricket, volley ball, Kho-Kho, Kabbaddi, etc.. For carrying out cultural activities a big auditorium is available in the institute. Apart from cultural activities various cocurricular activities are organised in this auditorium. Open theatre in the premises of the institute is also available for organising cultural and sports activities.

The institution makes use of IT facilities and it frequently updates it . The office of the institution makes use of software like college management system(CMS),MKCL,PayRoll, etc.

The computer facility is used by the students according to their needs. Computers are provided with upgraded antivirus. The library of the institute is partially automated. The library also has N-list and Libman software. The institute also has CCTV cameras, water purifiers, air conditioner, inverters, etc.

The institution tries its level best to help and support the students. The institution renders benefits of various types of scholarships of the Govt. for the students like Dr. Punjabrao Deshmukh Vastigraha Nirvah Yojana, Rajashree Chhatrapati Shahu Maharaj Shikshan Shulk Shishyavarti, Post Matric Scholarship to OBC, SBC, VJNT students and Government of India Post Matric Scholarship, etc.

The students are given the chance to pay the fees in installments. All the facilities of indoor and outdoor games are provided for the development of the students. Our institution encourages and inspires the students to take part in extracurricular activities.

We have in our college 'Career and Guidance Cell' and we guide the students to appear for competitive and other exams. We give the information about various job opportunities to the students by displaying the advertisement from Employment News, University News & Advertisement in various Newspapers on the notice board.

The student Council is formed. The members of Student's Council play important role in all programs organized by the institute. Through NSS students voluntarily participate in all activities organized by the institution like cleanliness programmes, blood donation camp,tree plantation drive, health check up of Warkaris in Dindi every year,etc.

We have in our college Women Cell, Grievance Redressal cell and Anti Ragging Committee which look after the problems and difficulties of students. We have provision for "Suggestion Box" which helps to solve the problems of students. The Grievance Redressal Cell takes every care to maintain free, fair and atmosphere in the college campus.

### Governance, Leadership and Management

The vision and mission of the institution is to take "the Ganges of knowledge" to the weaker and unprivileged section of society in the remote rural and hilly area of Beed district. The institution through its policies tries to give ample opportunities of higher education to the students of this region, develop their career and make them able and efficient support and pillars of our nation. The institute has decentralized activities related to teaching -learning, evaluation and administration. ### Institutional preparedness for NEP

1. Multidisciplinary/interdisciplinary:	Our institution is a multi disciplinary institution, which is affiliated to Dr. Babasaheb Ambedkar Marathwada University, Aurangabad. We offer programmes of Bachelor of Arts and Bachelor of Science in our institution. In arts faculty we offer courses in languages like Marathi, Hindi and English. The institution also offers the courses like history, sociology, political science, economics, geography , home science, physical education and public administration. The institution also runs PG courses in Marathi ,Hindi ,sociology, political science, geography and history. As far as Science faculty is concerned, we offer the courses like physics, chemistry, botany, zoology and computer science.
2. Academic bank of credits (ABC):	Our affiliating University Dr Babasaheb Ambedkar Marathwada University has taken an initiative for the implementation of New National Education Policy 2020 this year. Regarding this the comprehensive workshop of all the colleges affiliated with our University was organised. For the implementation of new national education policy, our institution has taken an initiative and we are making awareness among the students of the institution regarding Academic Bank of Credits . The faculty is guiding the students for the opening of individual academic accounts in the academic Bank of credits. The benefits of the academic Bank of credits are being conveyed to the students. The students are also being informed about the multiple entries and multiple exits of the system.
3. Skill development:	The institution is planning to create awareness among the students for acquiring skill development. The institution also has planned to begin some courses regarding skill development of the students.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	For the development of the nation and the individual as well fostering of Indian arts and culture is very pivotal. To understand the culture of the other region and languages it is very important to have a thorough understanding of the culture and the region of the self. It helps in establishing the Identity of an individual. Through it only the students can build a positive cultural identity and self esteem. The structure of a particular language determines a native speaker's perception of experience. Our institution offers courses in Indian languages like Marathi and Hindi. These courses help the students to understand

	the history ,culture and languages of India. These languages develop Indian sensibility and expression of once experience in a native tone. Even the courses of social sciences like history, sociology etc which are taught in the institution enhance the knowledge of the students regarding nation's cultural history and languages. Not only the courses of Arts faculty but also the courses of Bachelor of science faculty are also explained in Indian languages to the students for their comprehension and perfect understanding. Our institution has conducted online International lecture series in the subject of Hindi. The first theme of this lecture series was the status of Indian language Hindi in foreign countries. Another subject for this online lecture was the present status and direction of Hindi. One of the other themes was the job opportunities in Indian language Hindi. Our institution also organized online lecture on the theme of Present India and the relevance of Mahatma Gandhi's thoughts. Thus our institution offers courses in Indian languages.
5. Focus on Outcome based education (OBE):	Our institution focuses on outcome based education. The institution tries to provide a quality education to the students. The due emphasis is given on what the students are expected to know and what they should be able to do after the completion of a particular program and a particular course. For the knowledge of the students program outcomes and course outcomes are displaced on the institutional website. At the beginning of the academic year, the program outcomes and course outcomes are discussed with the students by all the faculty. The programme outcomes and the course outcomes are assessed by the respective departments of the institution.

For distance education our institution has joined Yashwantrao Chavan Maharashtra open University Nashik. Under this our institution runs preparatory programme.
